By completing and signing this form, we, the above-mentioned Club/Academy, hereby affirm, acknowledge, and agree to the following:

1. Participation Consent

We hereby release, discharge, and hold harmless to the Tournament Organizing Committee, sponsors, venue owners, match officials, volunteers, and all associated personnel from any claims, demands, actions, liabilities, losses, damages, injuries, costs, or expenses arising directly or indirectly from participation in the tournament.

6. Insurance Responsibility

We acknowledge that the organizer does not provide personal accident, medical, travel, or life insurance for participating teams, players, coaches, or officials. We understand that securing such insurance remains the sole responsibility of our Club/Academy.

7. Compliance with Tournament Rules

We agree to comply with all tournament rules, regulations, fixtures, disciplinary decisions, and directives issued by the tournament organizers.

8. Photography and Media Consent

We grant the authorized partners the right to photograph, film, record, and use images, videos, names, and likenesses of our players, coaches, and officials for promotional, marketing, educational, and media purposes without compensation.

9. Code of Conduct

We commit to maintaining the highest standards of sportsmanship, respect, discipline, and fair play throughout the tournament and understand that misconduct may result in disciplinary action or disqualification.
